······ THE BATTLE FOR THE SOUL OF OUR STATE BY CHRISTOPHER RUSSELL ······

Highlighted in the "Case Results" section on the back page of this newsletter is the reporting of a settlement of a wrongful death claim for one of our clients. We represented Gary, a devoted husband who lost his wife Linda, the love of his life, as a result of medical mistakes made by her doctor and a hospital that caused her to bleed to death due to simple miscommunication regarding a blood transfusion.

Gary and Linda had known each other for over 60 years, with their marriage being the second for both of them; they had found once again found love with each other. They did everything together, including camping, fishing and traveling; they were truly in their golden years. They had quite of bit of living left, since they were only in their 60s.

Gary, a 30-year veteran police officer, was satisfied with the settlement we obtained and glad to not have to go to the trial that was scheduled to resolve the matter. However, the \$175,000 settlement was in no way indicative of the loss Gary suffered. With so many years ahead of her, why was Linda's life worth only \$175,000? The answer to that question can be found within legislation that was passed in 1975, almost 40 years ago, which limits compensation to a surviving spouse in these types of medical malpractice claims to \$250,000. In terms of value, the \$250,000 awarded in 1975 is worth approximately \$62,000 in 2013 dollars. Conversely, if the \$250,000 was indexed for inflation, it would have a value of \$1,040,000 in today's dollars; yet, the insurance industry and medical community oppose any modification of the law. This means they believe the life of someone like Linda is really worth only \$62,000. The dirty little secret is that \$250,000 is never paid out, since that is the worst an insurance carrier can do at trial. That is why Gary's claim settled for \$175,000 despite our strong facts. In effect, Linda's life was not even worth \$62,000, but closer to \$43,000 in 1975 dollars.

I am telling the above story to alert everyone that after almost 40 years of its passage, there will be a proposition sponsored by various consumer groups on next year's ballot to modify this dehumanizing and unjust law. The law will only be changed via a proposition, as Sacramento will do nothing about it since the insurance industry funds every politician seeking re-election, and what politician is willing to bite the hand that feeds a re-election? Apparently none, if the last 40 years is any indication.

Regardless of whether you vote Republican or Democrat, valuing life at \$250,000 or \$62,000—or even \$43,000 as in the case of Linda—is an issue that goes to the soul of how we view each other as human beings, including our neighbors, our friends, our family and our spouses. Please be on the lookout for additional information as the election gets closer so you can make up your own mind as to how to vote on this important issue. I think you know which way Gary will be voting.

TWO GUYS' EASY APPLE PIE Re

Recipe by Jake & Marc Lazarus



1/3 to 2/3 cup sugar 1/4 cup all-purpose flour 1/2 teaspoon ground nutmeg 1/2 teaspoon ground cinnamon Pinch of salt 8 medium sized apples (about 1 cup) 2 tablespoons margarine

- Heat oven to 425 degrees.
- Peel, core and slice the apples. Try to keep the size of the slices even.
- Mix sugar, flour, nutmeg, cinnamon, and salt in large bowl.
- Stir in apples.
- Pour into pastry-lined pie plate.
- Dot with margarine.
- Cover with top crust and seal the edges. Cut slits in the top.
- OPTIONAL: Cover edge with 3-inch strip of aluminum foil to prevent too much browning. Remove foil during last 15 minutes of baking.
- Bake 40 to 50 minutes or until crust is brown and juice begins to bubble through slits in crust.

PERSONAL INJURY

Settled a case on behalf of a 13-year-old girl who lost 15% of her peripheral vision and now has an increased risk of glaucoma as a result of being shot in the eye by an airsoft pellet gun. The claim was settled one week prior to trial for **\$500,000**.

WRONGFUL DEATH
